The intent is to seek maximum participation of residents of the target areas to be served. Representatives are a fundamental source of information on conditions and problems of poverty. Low-income representation on the Board, on its committees and at neighborhood levels is critical to Community Action Partnership of Northeast Missouri's efforts.
